Consent, Release and Waiver of Liability

This Consent, Release and Waiver of Liability (the "Release") is hereby executed on the date written below by the parent or guardian of the minor child (under the age of 18) participant (the "Minor Participant") in favor of the American Cancer Society, Inc. ("ACS") and their affiliated partners and sponsors, including in each case, without limitation, their directors, officers, employees, volunteers, and agents (collectively the "Released Parties"). The Minor Participant, with the undersigned parent or guardian's full and voluntary consent, desires to engage in the American Cancer Society's Small Fry Tri: A Triathlon for Kids (the "Activity") and understands that his/her participation in the Activity will involve running, swimming, and cycling.

IN CONSIDERATION OF THE MINOR PARTICIPANT'S PARTICIPATION IN THE ACTIVITY, THE UNDERSIGNED IN HIS/HER CAPACITY AS MINOR PARTICIPANT'S PARENT OR GUARDIAN, HEREBY (A) ASSUMES ALL KNOWN AND UNKNOWN RISKS OF THE ACTIVITY AND GIVES PERMISSION FOR THE MINOR PARTICIPANT TO PARTICIPATE VOLUNTARILY IN THE ACTIVITY, AND (B) FOREVER RELEASES, WAIVES AND DISCHARGES ANY AND ALL LIABILITY, CLAIMS, AND DEMANDS OF WHATEVER KIND OR NATURE AGAINST THE RELEASED PARTIES, EITHER IN LAW OR IN EQUITY, TO THE FULLEST EXTENT PERMISSIBLE BY LAW, INCLUDING BUT NOT LIMITED TO THE NEGLIGENCE, FAULT OR MISCONDUCT OF ANY KIND ON THE PART OF THE RELEASED PARTIES, INCLUDING BUT NOT LIMITED TO DEATH, BODILY OR PERSONAL INJURY, ILLNESS, ECONOMIC LOSS OR OUT OF POCKET EXPENSES, OR LOSS OR DAMAGE TO PROPERTY, WHICH MINOR PARTICIPANT, HIS/HER HEIRS, ASSIGNEES, NEXT OF KIN AND/OR LEGALLY APPOINTED OR DESIGNATED REPRESENTATIVES, MAY HAVE OR WHICH MAY HEREAFTER ACCRUE ON THEIR BEHALF, WHICH ARISE OR MAY HEREAFTER ARISE FROM THE MINOR PARTICIPANT'S PARTICIPATION IN THE ACTIVITY.
